Reading Borough Council (RBC)

Autumn Report

The Cycle Forum meetings with RBC have been reported in previous issues of this newsletter. The agendas are normally long with inadequate time to raise and discuss all of the many issues that members raise, a matter that was discussed at the last RCC Open Meeting.

RBC has a list of requested schemes which is being used to record and monitor improvements. This started as a Town Centre list, but it now covers a slightly wider area. This has helped considerably in trying to progress the many action points that cyclists request.

Since the last issue of *CycleReading*, representatives from the RCC (John Lee) and Sustrans (Alex McKnight) walked around the Town Centre routes with RBC representatives (Simon Beasley and Emma Baker). The Council agreed to look at

improving many of the locations that we had suggested, including signing at the east of the Oracle, a route northwards through the Market Place, signing improvements at Town Hall Square, and improved links to the station and Forbury.

We hope that some quick actions will follow and a start will be made on the less straightforward suggestions. Without such changes to create clear through cycling routes in the town centre, the real potential for cycling in Reading will not be achieved.

The proposed new NCN route 422 from Newbury to Windsor will run through Reading on the A4 to the A329. The route proposals are now on the RCC website for your information and comments. Don't forget to send any comments to RBC, preferably with a copy to RCC.

RCC has already sent a range of general and detailed comments about the route alignment and proposed standard of the route. This is a large scheme costing £millions and taking many months to design and build, so you will be hearing more.

Wokingham Borough Council (WoBC)

Development continues within Wokingham. I've commented on the planning application for homes at Bell Foundry Lane, as usual asking for a wider foot/cycleway, and a raised table crossing for the access road.

I've also commented on the application for the Kennetmouth Park and Ride that WoBC is proposing to itself. The layout needs to be rethought for cycle and motorcycle parking, and to reduce the risk of people using buses colliding with people on bikes.

I understand that Sustrans and Thames Valley Park (TVP) are concerned by the way the plans disrupt the existing cycle route to TVP, and have suggested the existing NCN route along the Thames path could be improved as part of the plan.

Campaign News



Wokingham Borough have now resurfaced Smiths Walk in Woosehill - without any discussion with me or with Sustrans. The new tarmac is a great improvement and it has been widened, but it has also been converted from segregated cycle and footpath to shared use (see picture).

Although the cyclepath was only about 1m wide, my experience from using it twice a day was that it worked well because it encouraged people walking to stay on one side.

I look forward to having to say 'Excuse me please' much more

frequently in future. People walking don't like unsegregated routes and people cycling don't like unsegregated routes; why are they spreading?

I think it is because the path is 2.8m wide, and guidance from central Government requires 3.5m for segregated routes, so I wish there was a little more flexibility either in the guidance, or in WoBC's interpretation of it.

The route has also been extended with a new shared use path alongside the Emm Brook, which will provide a

very good place for children to learn to cycle, but doesn't link with anywhere else useful.

I have had a look at provision for cycling within the Montague Park development near the Coppid Beech roundabout, but it is at a very early stage.

I did discover that the toucan (pedestrian & cycle) crossing of William Heelas Way stays on red forever unless cars are present. I've asked for it to be fixed, but I suspect changing it to stay on green forever unless cars are present will not be the result.

Finally, Wokingham has a pollution problem. Shute End, Denmark Street, London Road and Twyford cross-roads all experience nitrogen dioxide levels higher than recommended safety levels. So WoBC is developing Air Quality Action Plans to reduce the levels.

Their press release recognises congestion as the major source and asks for ideas from local people so please get in touch with them, and me, with your suggestions.

Booking becomes Mandatory on GWR High Speed Trains

In May this year Great Western Rail introduced a 'booking only' policy for taking cycles on their high-speed trains. It seems that the main driver for this is GWR's planned introduction of a new design of high-speed trains that will come into service next year.

In a letter to Ben Howlett (MP for Exeter), the Managing Director of GWR stated: "We decided to make the change to mandatory booking on our High Speed Trains so that we could offer customers greater surety of getting their bike on board the train... We were also thinking ahead to our new trains. The new trains come in different formations, some will run as nine car services (carrying a maximum of ten bikes) some as five

car (carrying a maximum of four bikes) and some as two five car units (carrying a maximum of eight bikes).

"In addition, the new trains do not have guard vans, and cycles will be carried inside the train. Spaces are not all in one place, so unlike today where customers know to load their bikes at a single point, with the new trains booked spaces will be at either end and in the middle of the service.

"For ease of boarding, and to avoid frustration, and potential delays, of moving up and down the length of the platform to find a space, reservations on these trains will be essential for the cyclist to know where to board."

Of course many trips involving a bike on a train will not have a predetermined return time, and the booking only policy could lead to the senseless situation of guards refusing to let bikes

on a train when there are spaces available; hardly encouraging the promotion of a sustainable integrated transport system.

GWR has apparently briefed their staff to show discretion to cyclists who do not hold a reservation, subject to space being available on the train. Of course the application of discretion is going to be down to the individual GWR staff member, but my own experience on occasional trips between Reading and Oxford is that I have not yet been asked to show a cycle reservation.

Cycle reservations can be made when purchasing a ticket online, or by phone on the general GWR number 0345 7000 125, but the reservation needs to be made by 18:00 on the day before travel. Anecdotal evidence is that the phone reservation system is slow and only available in certain hours.

Other Cycling News

The Managing Director of GWR has admitted that the current booking system 'has a number of issues' and agrees that GWR needs to provide cyclists a live 'on the move' system that allows booking more closely to the time of travel.

To this end GWR has stated that it is "making changes to allow customers to reserve a bike space through its mobile app at the time of purchasing a ticket and this is due to be available in early autumn."

However, this will not help those people buying an open return, the very point of which is to provide flexibility on the return travel time. Therefore, what is more essential is a system whereby bike reservations can be made independently from the ticket purchase, and GWR say that they aim to have such a system in place by the start of the December timetable.

So it seems that cyclists may get a workable system, but we will have to wait and see what comes. If you want to keep the pressure on GWR then there is a petition on 38 degrees: <https://you.38degrees.org.uk/petitions/bike-reservations-on-trains-the-beginning-of-the-end/>.

Alternatively lodge an encouraging comment on the GWR complaints system <https://www.gwr.com/making-a-complaint/> - you might ask why GWR did not get a fit-for-purpose booking system in place before implementing the booking only policy.

Note that for the local (non-high-speed) trains there is no cycle reservation system. As for the new fleet of high-speed trains, let's hope that the on-board cycle storage is not a copy of the system used by Cross Country trains, where bicycle contortions are required in order to hang your bike in a wardrobe within a crowded doorway - a system that can only have been designed by someone who has never actually taken a bike on a train.

Cyclenation Needs a Voice from Reading

The Reading Cycle Campaign is affiliated to Cyclenation, an umbrella group for local cycle campaigns. Simon Geller from Cyclenation has requested someone from Reading to feed in views on cycle and rail integration. In Simon's words:

"The Cycle-Rail Working Group (CRWG) is tasked by the DfT to improve integration between rail and

cycling and meets about three times a year. It has representatives from across the railway industry and Martyn Brunt represents the voluntary / campaigning sectors.

"He in turn has a reference group comprising Roger Geffen from Cycling UK, Tom Bogdanowicz from London Cycling Campaign, Dave Holladay, who as you are probably aware is a walking encyclopedia of all things to do with railways and cycling, and myself representing Cyclenation.

"I've set up my own reference group comprising members of Cyclenation groups with whom I can confer on initiatives CRWG comes up with and pass on issues that are raised by the groups. All the work in my group is done by email - there is no requirement to attend meetings.

"So it would be great to have someone from Reading on the group."

Chairman's Letter

Dear RCC members,

As I am sure you know Team GB cyclists are the best in the world on the track, but they have done something remarkable with their legacy: they have called on the Prime Minister to invest in segregated cycle facilities as the Olympic legacy. A letter to Mrs May was signed by virtually every cycling medalist from Rio. Only Wiggins' name is absent, and given his recent comments on utility cyclists perhaps that is not such a bad thing.

The case was made in a video eloquently presented by Chris Boardman (why is he not a knight?), who has become a remarkable cycle campaigner. He lost his own mother a few weeks ago to a carelessly driven car. He knows full well the value of high quality cycle facilities.

Segregated cycle facilities are rare in the UK, but it is my belief that if we want to get lots of people cycling this is just what we need.

The new cycle superhighways in London are exactly that, properly segregated. They even have segregated traffic lights so that cyclists don't mix with vehicles when the lights change. This is commonly dealt with by some of us jumping traffic lights. Engineers have finally woken up to the value of that, and designed them so that cyclists have their own priority. That other great if odd campaigner, Boris, was the driving force behind the new breed of cycle facility. New for the UK that is. Most Northern European countries are already very good at doing this.

The call from our trackies is for investment: money to be spent on cycling. The Green Party asked for the same thing here a few months back. Predictably the proposal was met with scorn from our transport politicians. Investing in cycling is seen as a preposterous idea here, unless you look at the thin veneer of cycle friendliness that the Council likes to put on things. Scratch

that veneer and there isn't any real ambition to promote cycling here. There is a proposal for a new cycle route along the Bath Road heading to the west of Reading. It is almost exclusively a conversion to the pavement, with a few signs and lots of give way lines. It is not the sort of facility that will lead to a huge uptake in cycling all of a sudden.

It appears as if there is no real vision for what good cycle infrastructure should look like. A few years ago a man with a vision founded Sustrans and successfully bid for lottery funds to build it. There were people hired, deals done, land acquired and paths built. The idea was admirable, create a network of traffic free routes for cycling and walking all over the country. The money allocated for the whole country though was about half (£42 million) of what was spent some years later on one motorway junction (M4 junction 11 was £84 million).

Chairman's Letter

Here we are again, with £860 million to be invested in the M4 smart motorway, and no allocation so far for segregated cycling infrastructure. None at all.

When the Sustrans NCN was conceived and then built, it was a project for the new Millennium. It was recognised by all involved that it was going to be a project that had to be built super quickly and not to the ideal specification. Once it had been built, it would get used and it could be refined, added to and improved.

Sadly that vision never got beyond the building stage. It was seen as an encumbrance by local authorities, who, locally at least, pointedly refused to even keep it maintained, let alone upgrade any of it. The poor quality of construction soon needed some investment, and nobody would do it. Now the whole network around here has become a bit of a joke.

I use bits of it all the time, and when you compare it to something in the cities in Northern Europe it is pitiful. So now we have a new bit of Sustrans, Route 422, linking Windsor and Newbury. Much of this is claimed to exist and just needs some sig posting and some minor linkages. There is no ambition any more for a nice segregated facility. The cycle lanes in Berkeley Avenue are, for example, considered part of the scheme. These narrow bits of white paint are deemed to be an acceptable facility.

On the specifics of these cycle lanes let me explain what I see is wrong with them. They are too narrow for a start. I usually ride about 1.5 metres

away from the edge of the road, so that would put me outside the cycle lane. If I ride closer in, drivers are tempted to overtake by simply driving past without moving over. In my normal position if someone wants to get past they have to move over. It might seem counterintuitive, but it is much safer.

There are times when I will be even further over towards the middle of the road, places where I judge that it is too dangerous to be passed, so I won't let anyone past until I think it is safe. Now if you get a picture of how I ride you will see that I am a super-confident cyclist. It takes a lot of nerve to carve yourself space on the roads, and it isn't for everyone. Very very few people ride like that. And yes, I do get angry drivers, but not as many as you might think.

So the cycle lanes allow drivers to pass without moving over. They also encourage cyclists to overtake on the inside and make their way to the front of the lights, regardless of whether this is actually a good thing to do. They don't make anything actually safer, this white paint doesn't have any magic in it. And this is what is deemed to be a suitable facility to get a shift from driving to cycling. It won't make a blind bit of difference. It isn't going to get people leaving their cars at home and using a bike.

The cycle lanes in London, the new segregated cycle superhighways, already have cyclist traffic jams in busy periods. The numbers of users are truly staggering. Thousands of non-polluting journeys where people are getting their daily dose of exercise safely. Berkeley Avenue cycle lanes are hardly busy. There don't appear to be any more cyclists than there were before the paint went down. The new NCN422 won't solve the traffic queues heading along the Bath Road. Not a bit of it, so why bother with it?

What we need is a visionary and some money. Sadly there is no commitment to spend the money, and I can't see any cycling visionaries either.

ReadyBike



ReadyBike: what are the benefits and should it be subsidised?

ReadyBike may not be the runaway success that some people were hoping for. It could be argued that the cycling infrastructure is inadequate and too disjointed to support such a scheme. However, failure to attract the level of sponsorship to cover all the costs should not be a reason to discontinue ReadyBike without looking at the benefits of the scheme and how it compares in subsidy levels with other forms of transport in Reading.

Very few if any cycle hire schemes survive without subsidy. The wider benefits are normally considered; these include:

- Providing part of an integrated transport service
- Reducing car traffic and congestion
- Reducing pollution levels
- Encouraging health and fitness
- Encouraging others to cycle

Benefits

Hire bikes provide a useful part of an integrated transport system, allowing better access to many town centre areas as well as other areas that may have limited public transport access. Bicycles are not for all people so maybe we should also be considering electric hire bikes or even trikes?!

Having hire-bikes on the streets probably helps break down the barriers between cyclists and other

road-users and makes motorists more aware of cyclists. Hire bikes appear to generate a different response from motorists, who may treat them with more caution.

In London there was concern about the dangers of the 'Boris' bike, but this was largely unfounded, with probably lower collision rates than normal cyclists. This may be the same with ReadyBikes.

Subsidy

Most forms of transport are subsidised, including the railways, buses and the private car by road provision, or the £5,000 purchase subsidy for electric cars. In Reading there is free parking for the first car in residents' parking schemes and cheap rates for second cars. Is this a suitable subsidy?

Park and Rides normally have high subsidies, with those in Reading probably a few hundred pounds per user a year: I am currently trying to get the statistics.

So why not provide ongoing subsidies to ReadyBike, which also has the benefits of reducing pollution and traffic congestion, as well as improving the users' health?
